A recently added section, called the "Challenge Question," is part of an updated authentication security procedure required to verify your identity each time you call.

(Check the "Expires Upon Graduation" box and you won't have to fill this form out again—unless you want to change the required fields, such as who has access to your information.)

Please note: this form is for financial information only, not grades.

Why should I fill out this form?

Funding your college education is your responsibility; however, you may be getting help from a parent, relative, financial adviser, or donor. We will not be able to share your information without your consent. This form gives us your permission to talk about your financial situation with the individuals you choose.

Do I have to fill out this form?

You are not required to fill out this form if you plan to handle your bills and financial aid yourself. If you are unsure about signing the form, you should set an expiration date so there will be an end date to individuals' access to your information.

What happens if I don't fill it out?

If you choose not to fill out a FERPA form, our office will contact you directly with any billing or financial aid concerns. If someone calls to discuss your FAFSA, taxes, balance due, or refund check, we will not be able to disclose any information unless you have given them permission. If someone wants to pay your bill, we will not be able to disclose your balance to them.

What is the "Challenge Question"?

The Challenge Question is a question the financial staff will ask to verify the identity of an individual. It is important that this section is filled out and that the released individual retains a copy to remember the answer to the security question. Without the correct answer, the financial staff will not be able to discuss information protected by FERPA.
