

NOTICE TO EMPLOYEES

IN CASE OF A WORK RELATED INJURY

In the event of an emergency, please go to the nearest hospital for treatment.

- If you suffer a work related injury, your employer or its insurance company must pay for reasonable surgical and medical services and supplies, orthopedic appliances and prostheses, including training in their use.
- In order to ensure that your medical treatment will be paid for by your employer or the insurance company you must immediately advise your supervisor of your injury, and be treated by one of the licensed physicians or practitioners on the headings listed below

- If you need medical treatment for your work related injury you must continue to visit one of the providers listed above for ninety (90) days from your first visit. If you do not comply your employer may not be required to pay for these services.

- After this ninety (90) day period if you continue to require medical treatment and your employer provided the list set forth you may choose to go to another licensed physician or provider for medical treatment. You must notify your employer of this action within five (5) days of your visit to the provider of your choice or your employer may not be required to pay for these services.
- Your provider must file reports within ten (10) days for your first visit and thereafter at least once a month with your employer for as long as your treatment continues. Your medical bills may not be paid until each report is received.
- In the event a posted panel physician recommends invasive surgery, you may seek a second opinion with a physician of your choice. If you choose to undergo the invasive surgery, you may choose either the posted panel physician or the physician who rendered the second opinion.
- If no list is provided as above you may go to a licensed physician or provider of your choice.
- If one of the persons listed above refers you to another licensed specialist your employer or their insured will pay the bill for these services
- If you are faced with a medical emergency you may secure assistance from a hospital or physician or provider of your choice.
